Southeastern working hard to protect employees

Southeastern Hospital Supply Corporation is presently taking steps towards increasing their employees awareness of occupational safety hazards.

Recently Southeastern has established a Hazard Com-Standard munication (HAZCOM) to offer all employees information and training about chemicals handled in the work areas. Glen Carter, the HAZCOM

Coordinator, says "the HAZCOM program was developed by the Occupational Safety and Health Administration (OSHA) due to the concerns for occupational safety in the workplace. HAZCOM was initially designed for manufacturers, but was revised to include distributors such as Southeastern".

To increase the employees awareness of occupational safety, Trisha McPeak, Southeastern's materials clerk, began directing classes last month for all employees. In the classes, employees are introduced to the many features of the program and to the Material Data Safety Sheet (MSDS). This form lists everything known about one particular chemical. The MSDS also lists details on chemical dangers, physical dangers, safety procedures, and emergency response

techniques in case of accidents. There are still many steps that need to be taken before HAZCOM will begin protecting the employees here at Southeastern. The MSDS forms will be posted throughout the company anywhere chemicals are used. Also, all chemicals must be labeled with their name, physical hazards, storing instructions and health hazards. And according to Trisha, the most important factor which will determine if this new program is a success, "is the need for all the employees here at Southeastern to work together".

The Office Supply Swindle

Americans by the millions are finding out too late they have lost their life savings to a stock scam, travel club or vacation scam, bought a vacation to nowhere, safeguarded their money in a fake bank or loaned it to a leaky tax shelter.

The Direct Marketing Association issues Action Line Alerts when it discovers new swindles. Here is one all Southeastern employees should be aware of:

Be aware of callers who request the make and model of a copier (telex machine, computer, etc.). The caller's reason is given as a survey or serial number check. Sometime later, they call back and say, for instance, "you were overlooked when we notified our customers of a price change in toner; so I set aside two boxes for you at the old price."

Sometimes when the customers do

not order they are sent the merchandise anyway. When they don't pay, phone harassment begins.

Beware when the caller apologizes: "the computer was down, we're sorry we couldn't notify you earlier of the price change in toner..." or mentions a "shortage" or "overstock" that gives him the opportunity to offer a great price.

These "Toner phoners" and "paper pirates" are masters at implying they have done business with you before. Be suspicious of people who say they are calling from the "national distributorship of the local company you usually do business with." Also beware of people who call "to confirm an order previously placed by someone else at your company."

The Dress Code

No sundresses are to be worn without jackets.


There should be no cleavage shown.
